Appointment of future Acenda Group Chief Financial Officer and Chief Risk Officer

Acenda and Resolution Life Australasia congratulates Ms. Yvonne Le Bas and Ms. Karen Malzard on their appointment as the future Group Chief Financial Officer (CFO) and Group Chief Risk Officer (CRO), respectively, of the Acenda Group.

Ms. Le Bas and Ms. Malzard's appointments follow Nippon Life's announcement in December 2024 that it had agreed to acquire 100% of the shares of Resolution Life. On completion of this transaction, which is subject to regulatory approvals, Acenda and Resolution Life Australasia will merge to form the Acenda Group, one of the largest life insurance businesses in Australia and New Zealand.

The appointments further strengthen the leadership of the merged Group, together with the previously announced future Group Chief Executive Officer, Chris de Bruin, future Acenda Board Chair, Mr. Craig Dunn, and future Independent Non-Executive Directors. The appointments will take effect upon completion of the transaction.
