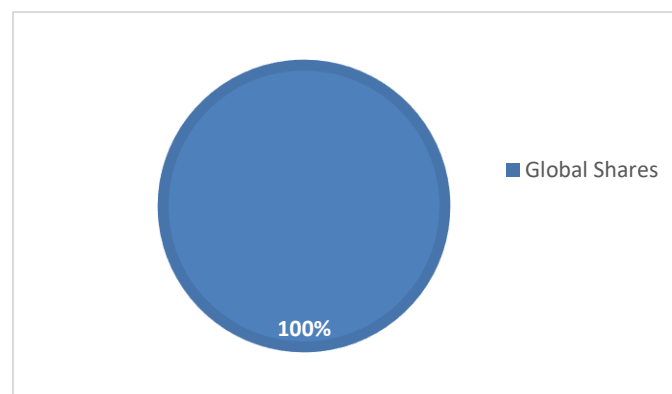
## Investment objective and strategy

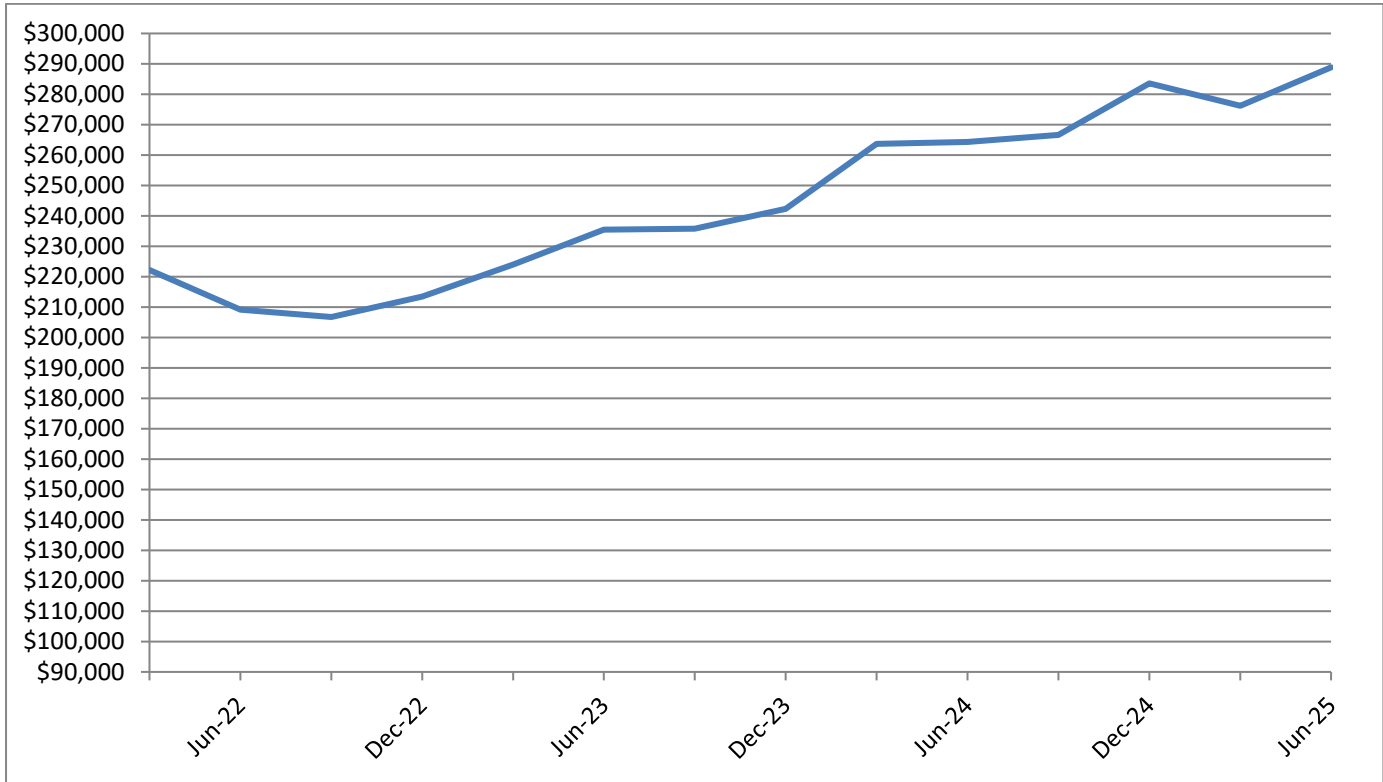
