How to have a Power of Attorney added to a policy

So that we can action your request, you need to provide the necessary documentation. This helps prevent fraudulent activity on your account and is required under certain laws

STEP 1

Print or make a copy of the original Power of Attorney. Make sure you copy both sides and include all pages.

STEP 2

The copy of your Power of Attorney needs to be certified by one of the people listed over the page. They will need to sight the original documentation to complete this request.

STEP 3

The certifier can certify the photocopy of your Power of Attorney by placing a stamp or writing 'This is a true and correct copy of the original' followed by their signature, printed name, qualification and the date.

The certifier MUST either:

- a. Repeat the above on each page; or
- b. Make reference to the total number of pages being certified on the front page and then proceed to initial, date and note each page number on each subsequent page.

STEP 4

All legal representatives noted on the Power of Attorney must also provide a copy of their own certified identification.

Please refer to the enclosed flyer 'How to confirm your identity' for the correct process.

STEP 5

Send the certified copy of the Power of Attorney with the certified identification to the postal address listed on the email you have received. We can only accept certified documents that have a certifier's original ink signature on them. Please don't email your documentation.

Once the documentation has been verified, as a Power of Attorney, you will be able to obtain specific policy information.

We may be restricted from providing some information over the phone, however, a written request signed by the attorney/s can be submitted and we will respond to the query, noting that any policy changes or transactions must be sent in writing.

 - c. Minister
 - d. Head of a Mission
 - e. Commissioner
 - f. Charge d'Affaires
 - g. Counsellor, Secretary or Attache at an Embassy, High Commissioner's office, Legation or similar

- · Bank officer with two or more continuous years of service
- Building society officer with two or more years of continuous service
- · Chief executive officer of a Commonwealth court
- · Clerk of a court
- · Commissioner for Affidavits

- Employee of the Australian Trade and Investments Commission who is:
 - a. in a country or place outside Australia and

 - a. in a country or place outside Australia and
 - b. authorised under paragraph 3 (c) of the Consular Fees Act 1955 and

- Holder of a statutory office not specified in another item in this list

- Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the Institute of Public Accountants
- · Member of:
- a. the Parliament of the Commonwealth or
- b. the Parliament of a State or
- c. a Territory legislature or
- d. a local government authority of a State or Territory
- Minister of religion registered under Subdivision A of Division
 1 of Part IV of the Marriage Act 1961
- · Notary public
- · Permanent employee of:
 - a. the Commonwealth or a Commonwealth authority or
 - b. a State or Territory or a State or Territory authority or
 - c. a local government authority or
 - d. With two or more years of continuous service and the person is not already specified in another item on this list
- Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made
- · Police officer
- · Registrar, or Deputy Registrar, of a court
- Senior Executive Service employee of:
 - a. The Commonwealth or a Commonwealth authority or b. a State or Territory or a State or Territory authority
- Sheriff
- · Sheriff's officer
- Teacher employed on a full-time basis at a school or tertiary education institution.
