Who is an acceptable referee?

- Accountants (members of the Institute of Chartered Accountants, the Australian Society of CPAs or the National Institute of Accountants)
- Alderman or councillors of municipal, city, town district or shire councils
- Bank, (in Australia or overseas), building society and credit union employees or agents authorised by their institution to open accounts
- Bailiffs, barristers, clerks of court, clerks of petty sessions, sheriffs, solicitors, stipendiary magistrates
- Commissioned officers currently serving in the defence forces
- Commissioners for oaths
- Dealers and investment advisers who are holders of an Australian Financial Services License
- Dentists, medical practitioners, nursing sisters, pharmacists
- Diplomatic or consular officers of an Australian embassy, high commission or consulate in Australia or overseas
- Financial Institution (other than an employee authorised to open accounts with the institution) and registered corporation (within the meaning of the *Financial Corporations Act 1974*) full-time employees who have been employed continuously for at least five years by one or more financial bodies
- Holders of statutory office for which an annual salary is payable
- Insurance company full-time employees who have been employed continuously for at least five years by such company
- Judges, masters, registrars of Federal, State and Territory courts
- Justices of the Peace
- Members of an aboriginal community council and recognised community elders of an aboriginal community
- Members of the Institute of Engineers, Australia (other than a student member)
- Member of the Institute of Corporate Secretaries in Australia Limited
- Members of Federal or State or Territory parliament
- Members or Fellows of the Association of Taxation and Management Accountants
- Member or Fellows of the National Tax and Accountants' Association Limited
- Ministers of religion
- Notaries public
- State or federal police officers in charge of police stations or officers of the rank of sergeant and above
- Postal managers
- Public employees – who have been employed for at least five years by a public authority
- Registered tax agents
- Teachers – full-time, with five years service
- Totalisator Agency Board (TAB) Agents (provided that the agency is not conducted in conjunction with any other business)
- Veterinary surgeons.
